## Determination of the court session

Having considered in the preparatory session on the lawsuit of Melikov Teymur Hasan Ali on the establishment of a legal fact

that plaintiff's brother Melikov Mekhti Hasan Ali oglu died in Iran and to receive his inheritance, he needs to have a brother's birth certificate, since the act record of his birth has not been preserved.

In this regard, the plaintiff asks to establish the fact of the place of birth of his brother, that is, Melikov Mekhti Hasan Ali oglu. The court examined the materials of the case and after hearing the witness the lawsuit is considered justified and thus guided by articles 8,118,176 of the Constitution of Azerbaijan SSR identified:

To admit the fact that Melikov Mehdi Hasan Ali oglu was indeed born in 1900 in the city of Baku from the marriage of Karbelay Hasan Melik Mamed oglu and Gulnisa Mammadrza kyzy Melikova.

The decision may be appealed within 5 days to the Supreme Court of the Azerbaijan SSR
